Subject: Admission of students under Prime Minister's Special Scholarship Scheme for UTs of J&K and Ladakh B.Sc (Nursing) programme in the academic year 2021-22 in colleges under Guru Gobind Singh Indraprastha University, Delhi-reg.

Sir,

This is with reference to your letter no. AICTE/Centralized Counselling/2021-22 dated 25.03.2022 addressed to The Principal Secretary (Education), Education Department, Govt of NCT of Delhi, old secretariat, New Delhi 110054 regarding subject cited above.

It is to inform you that the Delhi Professional College or Institutions (Prohibition of Capitation Fee) Act 2007, is applicable to all unaided Instutions affiliated to a University imparting education in degrees, diploma and certificate courses. As per this Act 2007, admissions in unaided affiliated institutions have to be on the basis of CET i.e. NEET UG. The Section 13, Sub Section 3(d) provides CET i.e. NEET UG is mandatory.

In order to ensure uniformity in admission criteria, the provisions of the Act, 2007 have been made applicable to both aided and unaided institute. Therefore, as prescribed under the provisions of the Act, 2007 the admission in B.Sc Nursing or in any other programme are on the basis of merit of entrance exam.

In addition to above, Government of India, DGHS, Nursing Section letter no. Z.28015/4/2012-N dated 04.03.2021 signed by Dr. Rathi Balachandran, ADG (Nursing) states that the decision of the competent authority regarding selection of candidates for admission to B.Sc (H) Nursing 2021 in the Nursing Institutions under Dte. GHS on the basis of marks obtained in NEET Examinations 2021. Further, in this letter, it is also stated that the information may be communicated to the candidates through the prospectus of institutions/NEET 2021(copy enclosed).


In view of the AICTE letter dated 25.03.2022, the university is in the process of taking up the case with Govt of NCT of Delhi for regularization of candidates as admitted by AICTE under Prime Minister Special Scholarship Scheme in B.Sc Nursing programme without NEET UG 2021 marks/score.

However, AICTE is requested to ensure that only NEET UG qualified candidates are considered for admission to B.Sc (H) Nursing programme under PMSSS for session 2022-23 and onwards and JEE qualified candidates for admission to B.Tech programme under PMSSS.
